The objective of this strategy is to target an annual return of CPIX plus 6%-7% over a rolling 60-month period and not to lose capital over a rolling 36-month period, while at all times remaining within Prudential guidelines.

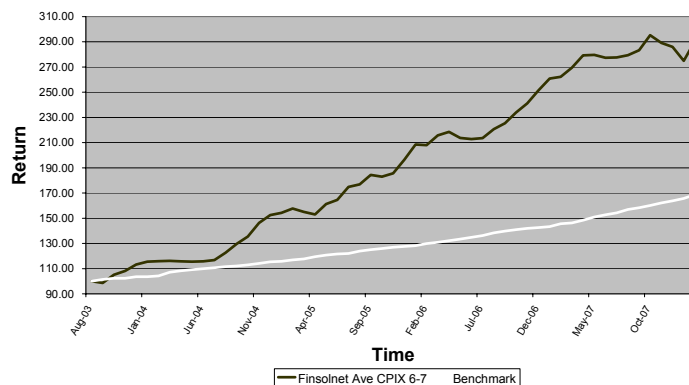

FUND COMMENT

The portfolio underperformed its benchmark during the 3-month period, returning 0.50% against the benchmark return of 4.03%. The portfolio continues to outperform its benchmark since inception.

Over the 3-month period to the end of February 2008, the FTSE/JSE All Share Index returned 1.52%, the All Bond Index returned -0.51%, cash returned 2.57% and the South African Property Index returned -9.55%. During the same period, international equities returned 3.23% and international fixed interest returned 20.76%. International fixed interest was the best performing asset class followed by international equity. The Rand depreciated by 14.27% against the US dollar over the period positively impacting the international assets within the portfolio.

The current rise in inflation has meant that the benchmark has been difficult to beat. Inflation as measured by CPIX ended the 12 month period at 8.76%, significantly above the target range set by the SARB. All of the underlying funds under performed the benchmark during the 3 month period.
