The objective of this strategy is to target an annual return of CPIX plus 6%-7% over a rolling 60-month period and not to lose capital over a rolling 36-month period, while at all times remaining within Prudential guidelines.

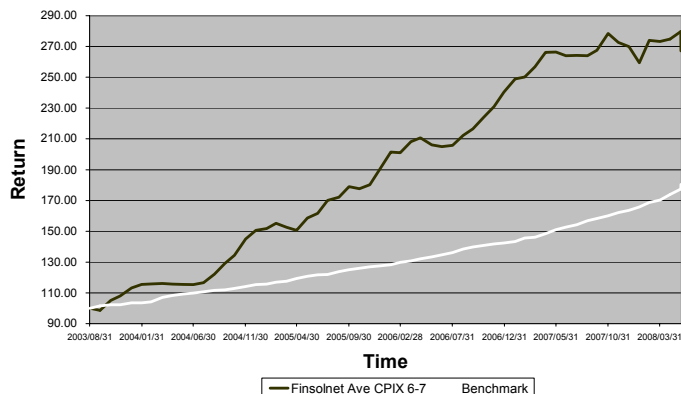

**FUND COMMENT**

The portfolio underperformed its benchmark during the 3-month period, returning -2.29% against the benchmark return of 5.95%. The portfolio continues to outperform its benchmark since inception.

Over the 3-month period to the end of June 2008, the FTSE/JSE All Share Index returned 3.36%, the All Bond Index returned -4.89%, cash returned 2.74% and the South African Property Index returned -19.65%. During the same period, international equities returned -6.03% and international fixed interest returned -7.75%. Local equity was the best performing asset class followed by local cash. The Rand appreciated by 3.19% against the US dollar over the period having a negative impact on the international assets within the portfolio.
