STRATEGY OBJECTIVE

The objective of this strategy is to target an annual return of CPIX plus 4%-5% over a rolling 36-month period and not to lose capital over a rolling 24-month period, while at all times remaining within Prudential guidelines.

COMMENTARY

The portfolio underperformed its benchmark during the 3-month period, returning -2.30% against the benchmark return of 5.87%. The portfolio continues to outperform its benchmark since inception.

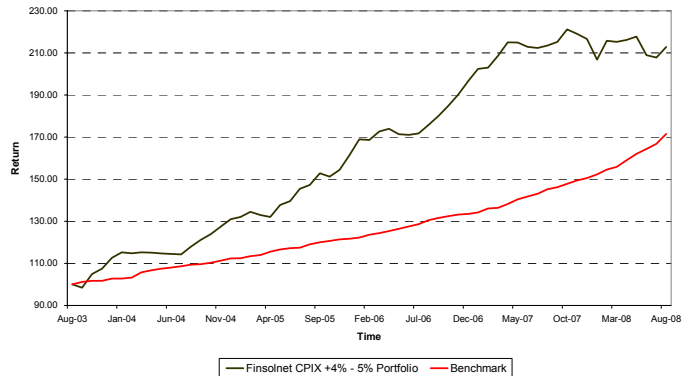
Over the 3-month period to the end of August 2008, the FTSE/JSE All Share Index returned -12.42%, the All Bond Index returned 8.00%, cash returned 2.88% and the South African Property Index returned 16.15%. During the same period, international equities returned -11.30% and international fixed interest returned -0.75%. Local property was the best performing asset class followed by local bonds. The Rand depreciated by 1.16% against the US dollar over the period having a negative impact on the international assets within the portfolio.
