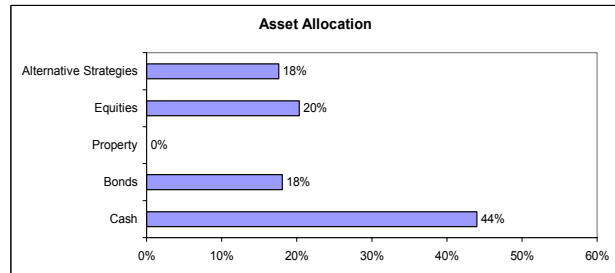
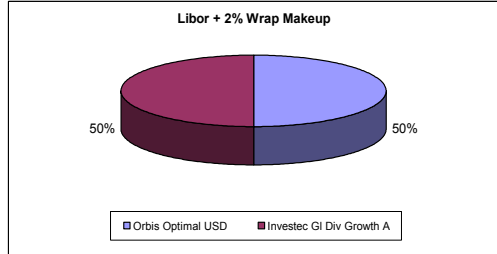


Table comparing Investec GI Div Growth A (1) and Orbis Optimal USD (0.32) on a scale of 1.

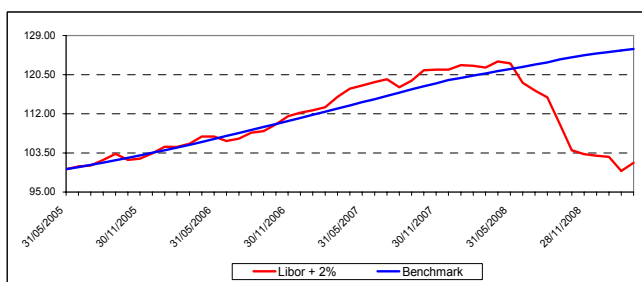


Table titled 'Libor + 2% Strategy (USD)' showing monthly performance from 2005 to 2009 for Wrap and Bench columns.

FUND COMMENT:
March saw the strategy outperform its benchmark, returning 1.79% against the benchmark's 0.26%.
The strategy has underperformed its benchmark since inception with a total return of 1.37% against the benchmark's 26.08%.

In terms of individual fund performance against the benchmark, both the underlying funds managed to outperform the benchmark during March. The Orbis Optimal USD Fund was the better performing fund, returning 2.43%.

The overall risk of the portfolio is low relative to that of the MSCI World Equity Index and the correlations of the underlying funds are very low, adding to the diversification within the strategy.

FUND COMMENT:
 March saw the strategy outperform its benchmark, returning 7.18% against the benchmark's 0.43%. The strategy has underperformed its benchmark since inception with a total return of -13.93% against the benchmark's 35.82%.

In terms of individual fund performance against the benchmark, both the underlying funds managed to outperform the benchmark during March. The Orbis Global Equity Fund was the better performing fund, returning 8.98%.

The overall risk of the portfolio is low relative to that of the MSCI World Equity Index and the correlation of the underlying funds are low, adding diversification within the strategy.
