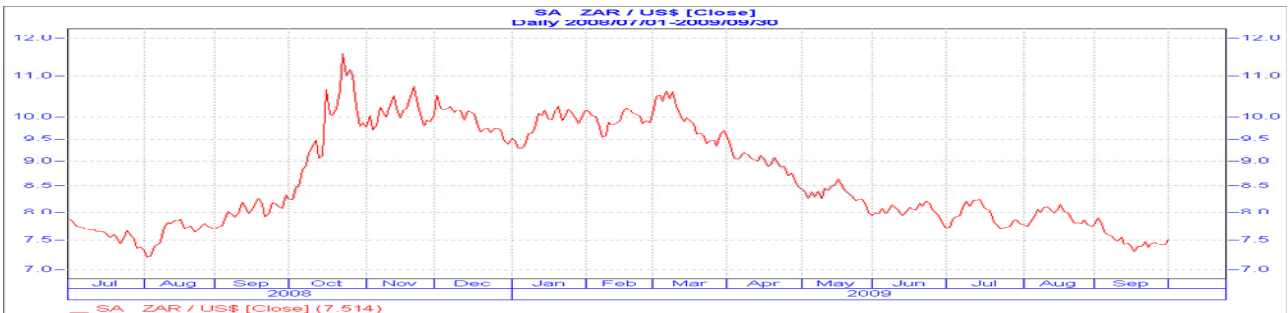


FUND COMMENT:
 September saw the strategy outperform its benchmark, returning 2.59% against the benchmark's 0.19%. The strategy has underperformed its benchmark since inception with a total return of 17.75% against the benchmark's 27.69%.

In terms of individual fund performance against the benchmark, both the underlying funds managed to outperform the benchmark during September. The Investec Gbl Diversified Growth Fund was the better performing fund, returning 4.09%.

The overall risk of the portfolio is low relative to that of the MSCI World Equity Index and the correlations of the underlying funds are very low, adding to the diversification within the strategy.

FUND COMMENT:
 September saw the strategy outperform its benchmark, returning 3.99% against the benchmark's 0.35%. The strategy has underperformed its benchmark since inception with a total return of 23.91% against the benchmark's 38.90%.

In terms of individual fund performance against the benchmark, both the underlying funds managed to outperform the benchmark during September. The Orbis Global Equity Fund was the better performing fund, returning 4.35%.

The overall risk of the portfolio is low relative to that of the MSCI World Equity Index and the correlation of the underlying funds are low, adding diversification within the strategy.
