**STRATEGY BENCHMARK**

Inflation (CPIX) plus 6%-7%

**STRATEGY OBJECTIVE**

The objective of this strategy is to target an annual return of CPIX plus 6%-7% over a rolling 60-month period and not to lose capital over a rolling 36-month period, while at all times remaining within Prudential guidelines.

**FUND COMMENT**

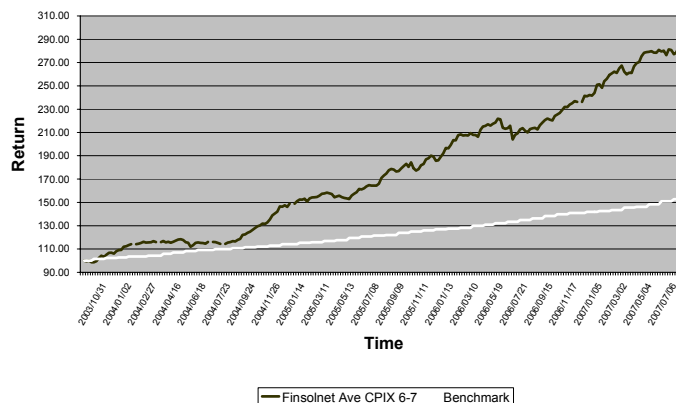
The portfolio underperformed its benchmark during the 3-month period, returning -0.61% against the benchmark return of 4.02%. The portfolio continues to outperform its benchmark since inception.

Over the 3-month period to the end of July 2007, the FTSE/JSE All Share Index returned 1.75%, the All Bond Index returned -2.81%, cash returned 2.23% and the South African Property Index returned -6.67%. During the same period, international equities returned 0.17% and international fixed interest returned 1.21%. Local cash was the best performing asset class. International fixed interest outperformed international equity on the back of investors selling risky assets due to the sub prime issues in the US.

The Investec Opportunity Fund was the only fund able to beat the benchmark during the past 3 months.
